Global Search of Sage 100 Data

On the Home tab, click the Global Search button to perform a global search in Sage 100 data. For example, you can search to find all inventory items that are in a specific default warehouse or all Accounts Receivable invoices associated with a specific salesperson.

Global Changes

The following changes are carried throughout multiple modules.

Expanded Lot/Serial Number Field

The lot/serial number field has expanded from 15 to 50 characters in length in the following modules: Accounts Receivable, Bill of Materials, Common Information, Inventory Management, Mobility for Bar Code, Production Management, Purchase Order, Return Merchandise Authorization, and Sales Order.

The following changes have been made for this feature:

- In Inventory Management Options, the Zero Fill Lot/Serial Number check box has been added, giving you the option to insert leading zeros automatically to pad numeric lot/serial numbers.
- Lot/Serial number entry fields display the full 50 characters (for example, Lot/Serial Number Distribution and Next Lot/Serial Number field).
- Lot/Serial number columns in list views display 20 characters and can be expanded to display the full 50 characters (for example, Lot/Serial Transaction Inquiry and Lot/Serial History Inquiry).

Existing lot/serial numbers are not automatically converted to the new length.

Lot/Serial Number Conversion Utility

The Lot/Serial Number Conversion Utility has been added to the Utilities menu. In the Sage 100 Desktop, select File > Run. In the Run Program window, enter *utl in the Program field to open the Utilities menu.

Use this utility if you want to convert your existing numeric lot/serial numbers to the new length of 50 characters by inserting leading zeros. Lot/Serial numbers containing characters, or a combination of numerics and characters will not be changed.

Expanded Price Level Field

The Price Level field has been expanded from 1 to 15 characters in the following modules: Accounts Receivable, Customer Relationship Management, Inventory Management, eBusiness Manager, Job Cost, Return Merchandise Authorization, and Sales Order. Task windows, forms, and reports have been updated to reflect this change.

Expanded Package Tracking Number field

The Sales Order Package Tracking Number field has been expanded from 30 to 40 characters to fit the longer tracking numbers used by shipping carriers and services, such as FedEx Ground and DHL eCommerce. Task windows, forms, and reports have been updated to reflect this change.

New Filter Option for Custom Lookup Views

In the User Lookup Wizard, the filter option Is Empty has been added to the Operand field in the custom filters screen.

Lookup Listing Prints All Modified Lookups

A Print button has been added to the User Lookup Wizard, enabling you to print the Lookup Listing with all default and modified lookups. The Level column on the listing indicates where the lookup was modified. For more information, see User Lookup Wizard in Sage 100 help.

User Interface Enhancement

To make it easier to access data and complete tasks, in A/P Invoice History Inquiry, A/R Invoice History Inquiry, and RMA Inquiry, hyperlinks to related tasks (such as Vendor Inquiry or Customer Inquiry) have been added where applicable.

Show/Hide Password

Click the new Show/Hide () button next to each Password field in Sage 100 to double-check the value you're entering. After tabbing off the Password field, the password can no longer be viewed.

Installation Changes

The following installation changes were made.

64-bit Version of Sage 100

Important! Sage 100 2026 is a 64-bit only application.

- If you're installing on a server with an earlier 32-bit version of Sage 100 2021-2025 installed, **the 32-bit version will no longer work.**
- Before installing Sage 100 2026, we recommend converting any earlier 32-bit versions to 64-bit using the 32_64_Bit_Switch_Utility.exe. For more information, see the *Customer Upgrade Guide*.
- If running the switch utility is not possible, then install Sage 100 2026 on a server that does not have a 32-bit version installed.

Sage CRM Installation Changes

The option to **Install Sage CRM or Upgrade Sage CRM** has been removed from the Sage 100 installation program. For information on installing or upgrading Sage CRM, see the [Sage CRM Help Center](#).

Use the Sage 100 2026 CRM file to integrate Sage CRM with Sage 100.

SAP Crystal Reports 2025

SAP Crystal Reports has been updated to version 2025. Crystal runtime components are SP34 for both x86 and x64.

Product Key Registration Improvements

When installing and registering Sage 100, the full product key can now be pasted into the first segment of the Product Key field and the system automatically splits the key across all segments for your ease.

Custom Office

The following change was made in the Custom Office module.

Tables with User-Defined Fields Flagged for Easy Visibility

In User-Defined Field and Table Maintenance, to help you identify tables that have one or more UDFs defined, the **[UDF]** tag now displays after the table name. You can also use the Table Search feature to search for **UDF** and all tables with this tag will display.

Inventory Management

The following changes were made in the Inventory Management module.

Track Lot Code Source

You can now track lot code source and country of origin for items on the FDA Food Traceability List (FTL) that must be tracked per the Food Safety Modernization Act (FSMA). The lot code source is a 50-character alphanumeric field that identifies the location where the original lot code was assigned.

The following changes have been made:

- Changes in Inventory Management Options:
 - The Lot/Serial Expiration options originally on the Additional tab have been moved to the new Lot/Serial tab.
 - The Enable Tracking of Lot Code Source check box has been added on the Lot/Serial tab.
- The Track Lot Code Source check box has been added in Item Maintenance and Product Line Maintenance.
- The Lot Code Source and Country of Origin entry fields have been added in the Lot/Serial Number Distribution window accessed from I/M Transaction Entry, Physical Count Entry, S/O Invoice Data Entry, P/O Receipt of Goods Entry, RMA Entry, and RMA Receipts Entry.
- The Lot Code Source History Report has been added on the I/M Reports menu.

Note: This feature is available if you purchased Sage 100 through a subscription plan.

Improved User Workflow

The order of tabs in Product Line Maintenance has changed to support a more efficient user workflow. Lot/Serial is now the second tab, and Accounts is the third.

Improvements for Calculating Inventory Quantity Available

In Inventory Management Options, two new options have been added in the Include in Quantity Available field: **Required for W/Ts and POs** and **Required for W/Ts**.

These options calculate the quantity available by only including the quantity required for work tickets (materials) and excluding the quantity on work tickets (finished goods). This allows the raw materials to be included in the calculation so that the component availability is not overstated and the finished goods availability is not overstated.

Inventory Requirements Planning

The following change was made in the Inventory Requirements Planning module.

Warehouse Groups

You can now define one or more warehouse groups in Warehouse Group Code Maintenance, a new task on the Setup menu. Warehouse groups are used by the IRP Generation process to consolidate recommendations for material acquisitions or to recommend the transfer of inventory from one warehouse to another. This functionality was in the Material Requirements Planning module and has now been added to IRP.

This feature includes the following changes:

- The Enable Warehouse Grouping check box has been added in Inventory Requirements Planning Options.
- The Warehouse type field has been added in Warehouse Code Maintenance, and you can identify a warehouse as a Standard or Transfer type.
- When warehouse grouping is turned on, Items to Produce/Purchase, Item Detail, IRP Inquiry, and the Inventory Requirements Planning Report display information for warehouse groups.

Library Master

The following changes were made in the Library Master module.

Enhanced Password Validation and Security

On the System Configuration Security tab, the password setting options in the Internal Security section are now available and selected by default. This change enables password validation to occur, whether passwords are required or not.

In addition, the **Maximum Hours Session Can be Inactive** field has been added to improve security. You can set the number of hours the software can be inactive before a user is automatically logged out.

User Interface Improvement in Company Maintenance

In Company Maintenance, the **Payments** tab has been renamed **Integrations** to describe the options available. Also, the Enable Sync for Sage Supply Chain Intelligence check box has been added.

Audit Tracking for Roles and Users

You now have the option to retain an audit trail of all changes, deletions, and additions to role and user information. This feature includes the following changes:

- In System Configuration, the **Enable Audit Tracking for Role and User Maintenance** check box has been added.
- The new Role Audit Report and User Audit Report are available on the Reports menu when audit tracking is enabled.
- Click the Purge button on the audit report to access the Purge Role Audit Report or Purge User Audit Report utility. You can also access these tasks on the Utilities menu.
- In Role Maintenance and User Maintenance, click the new Audit Viewer button to view changes in the Audit Activity window. This feature is available if the user has permissions to the audit reports in Role Maintenance.

New Form Printing Message for Subscription-Only Installs

After forms are printed, a message appears to remind you to remove forms from the printer and replace with paper. If you don't want this message to appear, you can turn it off in Role Maintenance.

To prevent confusion, this message is now two separate messages. If you're on a subscription-only install, the message now refers to the Role Maintenance Security Options tab. If you're on a non-subscription install, the message refers to the Role Maintenance Module Options tab.

Paperless Office

The following changes were made in the Paperless Office module.

Consolidated Emails for Customers and Vendors

You can now consolidate multiple forms into one email for a specific customer or vendor and selected form. For example, if you're sending 10 invoices to a customer, then only one email with all 10 invoices will be sent instead of 10 individual emails.

You also have the flexibility to zip multiple forms into a single attachment on consolidated emails, and you can schedule the delivery of consolidated emails using Task Scheduler.

This feature includes the following new options:

- Consolidate E-mails check box in Default Delivery Options
- Consolidate E-mails for Customer check box and Consolidate E-mails for Vendor check box in Paperless Office Delivery Options
- Zip Multiple PDFs on Consolidated E-mails check box and Minimum Number of PDFs to Zip field in Paperless Office Options

This feature includes the following new tasks on the Paperless Office Main menu:

- Deliver Consolidated Customer E-mails
- Deliver Consolidated Vendor E-mails

Print Sales Order Picking Sheets to PDF

You can now print Sales Order picking sheets to PDF and email them to recipients in the warehouse. When Paperless Office is set up for forms, the Paperless button is available in Warehouse Code Maintenance. Click this button to define default email recipients for the selected warehouse in the new Paperless Office Delivery Options (Warehouse Code Maintenance) task.

If there's a business need, the Sales Order picking sheet can also be emailed to the customer by defining settings in Default Delivery Options and Paperless Office Delivery Options (Customer Maintenance).

Scheduled Email Attachments

On the Form Maintenance Main tab, the Scheduled Attachments button has been added. Use this time-saving feature to set up and schedule additional attachments to email with a form.

Option to View All Journal and Register PDF documents by Module

The new Role Maintenance security option **Allow Viewing of Journal and Register PDF Documents for Users Without Permissions to Task** allows users to view Journal and Register PDF documents when they do not have permissions to the task that created the PDF. For example, a user can view PDF documents for the Cash Receipts Register, even if they do not have permissions to the Cash Receipts Register task.

Improvements to Email Messages

In Electronic Delivery Message Maintenance, the selections at the Document field have been expanded so that you can now create unique email messages for specific documents in a document group. For example, in the S/O Invoice document group, you can create unique messages for a credit memo or debit memo.

Also, use the new Copy From button to copy an existing email message record and then modify it to meet your business needs.

Production Management

Option to Print Items with Zero Quantity Short Balances

On the Material Shortage Report, you now have the option to print items that have all entries with a quantity short equal to zero.

Purchase Order

The following changes were made in the Purchase Order module.

Option to Skip Prompt for Cancellation Code

The Cancel/Reason Code Req When Deleting Orders/Quotes field in Purchase Order Options has been enhanced. You now have the option to skip being prompted for a cancellation code when a purchase order/quote or line is deleted and a cancel/reason code is not required.

Sales Order

The following changes were made in the Sales Order module.

Option to Suppress Zero Cost Warning Message

You have the option to suppress the Zero Cost Warning message that appears in Sales Order data entry with the new Role Maintenance security option, **Display Zero Cost Warning for Miscellaneous and Special Items**.

Option to Suppress Purge Message

You have the option to suppress the purge message that appears after printing the Daily Shipment Report with the new Role Maintenance security option, **Allow Purging of Daily Shipment Report**.

View Sales Order Total

The Order Total field has been added on the Sales Order Entry Payment tab and is available when entering a credit card deposit. The Invoice Total field has been added on the S/O Invoice Data Entry Payment tab.

Option to Print Lot/Serial Information

On the S/O Additional Packing List form, you now have the option to print lot/serial information for items, which includes lot code source and country of origin.

Option to Skip Prompt for Cancellation Code

The Cancel/Reason Code Req When Deleting Orders/Quotes field in Sales Order Options has been enhanced. You now have the option to skip being prompted for a cancellation code when a sales order/quote or line is deleted and a cancel/reason code is not required.

Access Sales Order Memos in Shipping Data Entry

The Memo button has been added next to the Order Number field in Shipping Data Entry. To use the Memo button, enable it in Memo Manager Maintenance.

Visual Integrator

Improvements in the Expression Builder

The following improvements have been made for creating complex expressions and calculations in the Expression Builder for import or export jobs.

- When selecting a field or operator, the selected string is now inserted where the cursor is located in the calculation at the Expression Text field.
- The less than sign (<) and greater than sign (>) have been added to the list of Functions & Operators.

- Use the Allow Sync for Sage Supply Chain Intelligence check box in Vendor Maintenance to determine if purchase orders for a specific vendor sync.
- Use the Sync to Sage Supply Chain Intelligence check box in Purchase Order Entry to determine if a specific purchase order syncs. This check box can only be viewed in Purchase Order History Inquiry.

On the Web Content tab, the Resources button has been removed. For a one-stop shop to the Sage Community Hub, Knowledgebase, Product Documents page, Sage University, and additional services, click the Resources button on the Help tab instead.

To access file layout and program information, visit the [Sage 100 Documents page](#) and then select Sage 100 2025 > Administrator and Technical Documentation.

Global Changes

The following changes are carried throughout multiple modules.

Option to Expand the Accounts Receivable Invoice Number

You can now expand the invoice number length from 7 to 20 characters in the Accounts Receivable, Sales Order, and Job Cost modules. In Common Information Options, use the **Select the maximum length of the invoice number** field to increase the length up to 20 characters to meet your business needs.

Forms, reports, and screens are automatically changed to accommodate the expanded invoice number. Existing invoice numbers are not automatically converted to the new length.

A/R Invoice Expansion Conversion Utility

The A/R Invoice Expansion Conversion Utility has been added to the Utilities menu. In the Sage 100 Desktop, select File > Run. In the Run Program window, enter *utl in the Program field to open the Utilities menu.

Use this utility if you want to convert your existing 7-digit numeric invoice numbers to the new invoice number length. Invoice numbers containing characters, or a combination of numerics and characters will not be changed.

Audit Tracking for Sales Orders and Purchase Orders

You now have the option to enable audit tracking for sales orders and purchase orders. This feature includes the following highlights:

- In Sales Order Options and Purchase Order Options, the Changes to Track field and Track Additions in Detail check box have been added.
- You can retain an audit trail of all changes, deletions, and additions.
- When the option to track All is selected, the new Sales Order Audit Report and Purchase Order Audit Report are available.
 - A Purge button on the audit report provides access to the new Purge Audit Report utility. You can also access the utility on the Utilities menu in each module.
- In Sales Order Entry and Purchase Order Entry, click the new Audit Viewer button to view changes in the Audit Activity window. This feature is available if the user has permissions to the audit report for the module in Role Maintenance.

Copy Package Tracking Number in Accounts Receivable and Sales Order

In Summary Package Tracking, click the new Copy Tracking Number to Clipboard button to quickly copy a tracking number into an email or document.

Accounts Payable

The following change was made in the Accounts Payable module.

Switch View button in Invoice Payment Selection

The Switch View button has been added in the Select Invoices for Payment window, enabling you to toggle between the grid view and list view. Click the button to use the list view where you press CTRL + SHIFT to select invoices. Or click the button again to use the grid view where you use the Include check box to select invoices. The selected view will persist by user.

Microsoft 365 Connector and Office 365 Contacts

The Microsoft 365 Connector and Office 365 Contacts are now retired in Sage 100 version 2025. The interface to bring customers onto the Connector was deprecated by Microsoft in April 2024, and these add-ons are no longer available in version 2025.

SData Security

In Role Maintenance, the SData Security tab has been removed for both subscription and non-subscription versions of Sage 100.

In System Configuration, the Enable Native SData Provider and Access within Role Maintenance check box has been removed.

With the retirement of SData Security, the option to install the Native SData Provider Adapter has been removed from the Productivity Applications screen (accessed from the Sage 100 Autorun.exe).

Vault-Only Accounts

On August 1, 2024, Nuvei/Paya discontinued the creation of vault-only accounts to improve security and payment card industry (PCI) compliance. A vault-only account is an account used to store the last 4 digits of a credit card; it cannot be used to process credit card transactions.

In Sage 100 2025, vault-only accounts are no longer automatically created. You must have a Nuvei/Paya merchant account to add credit cards for new customers. Also, the following changes have been made:

- In A/R Payment Type Maintenance, if you remove the virtual terminal ID and merchant key for a credit card payment type and click Accept, a message will appear to notify you that credit card records will be disconnected from Nuvei/Paya. At this message, you can click Yes to disconnect the credit card record from Nuvei/Paya, or click No to return to Payment Type Maintenance and enter a virtual terminal ID and merchant key.
- When adding a credit card on-the-fly in an Accounts Receivable or Sales Order data entry task, a virtual terminal ID and merchant key must be defined for the credit card payment type in Payment Type Maintenance or Company Maintenance to save the credit card record.
- When copying a company in Company Maintenance, the source company's virtual terminal ID and merchant key for credit card payment types are not copied to the destination company.

Consolidate Demands

Demands are now consolidated for the same item when creating a work ticket or purchase order to stock. This enhancement allows you to create one work ticket or purchase order for multiple demands on the same item, instead of creating a separate work ticket or purchase order for each demand. Demands for the same item are consolidated automatically if the item's procurement type is Make to Stock or Buy to Stock.

In addition to suppressing the automatic display of the extended item description in Item Maintenance, you can now also suppress it in data entry tasks when the item description is in the primary grid and an item is entered on a new line in the grid or when tabbing past the item on an existing line.

SSCI bridges the gap between issuance of a purchase order and receipt of goods, providing a cloud-based way to collaborate with suppliers, consolidate shipments, create custom P/O workflows, and even create and edit purchase orders, and have the data flow back into Sage 100.

Use the Sage Supply Chain Intelligence Setup app to perform integration for Sage 100 2025, 2024.2, and 2023.5.

When a Sage 100 company is integrated with Sage Connect, the Enable Sync for Sage Connect check box is selected by default on the Company Maintenance Payment tab.

Production Management

View Quantity Remaining in Materials Where-Used Inquiry

A new Quantity Remaining column (displaying the quantity required minus the quantity issued) has been added in the Materials Where-Used Inquiry window.

In addition, if the selected item is the parent of a work ticket, the following changes have been made:

- Description column displays "Parent Item Code"
- Step Number, Activity Code, and Work Center columns are blank
- Due Date column displays the work ticket production due date

Sales Order

Option to Relieve WIP Based on Percent Complete

The Relieve WIP Based on Percent Complete check box has been added on the Work Ticket Entry Header tab and the Work Ticket Class Maintenance Main tab. Select this check box to use the prorated cost for WIP when entering a partial completion in Work Ticket Transaction Entry.

Explode Bill Subassemblies

In Work Ticket Entry, the Explode Subassemblies check box has been replaced by the Explode Bill Subassemblies field. When the Bill of Materials module is integrated with Production Management and enhanced scheduling is used, selecting Yes at the Explode Bill Subassemblies field now creates work ticket steps for each subassembly on a multilevel bill. This functionality was in the Work Order module and has now been added to Production Management.

Explode Template Subassemblies

During the copy process, the system will calculate the number of days between the start date entered here and the source work ticket start date. The difference between the dates will be used to automatically adjust all of the scheduling dates in the source work ticket steps as they are copied.

Create Work Ticket with Materials From Option

A new option has been added in Production Management Options, enabling you to create a work ticket using the materials from the bill, work ticket template, both the bill and template, or you can select to be prompted with a message in Work Ticket Entry asking which materials to use.

Data Conversion for Earlier Version of Production Management

The Production Management module code has changed from JT to PM. When you convert Production Management data from an earlier version of Sage 100, the converted company data files are changed to use the PM prefix.

Important! If you're upgrading from the standalone version of Production Management that was previously available, you must be on version 2021.x of the standalone version before upgrading to the Production Management module that is part of Sage 100 2023.

When selected, you can define filters and apply them to one or more of the fields to limit the rows displayed in the Key Scan screen. The status text on the Key Scan screen will indicate when a filter is active.
- **Map Service:** An option has been added on the Preferences tab in User Maintenance allowing you to select which map service to use when clicking the Map button in Sage 100 tasks. Use Google Maps, Bing Maps, or MapQuest.

Labor entries are no longer updated to the Payroll module by updating the Periodic Labor Register. Instead, you now import labor entries into Payroll using the **Labor** button on the **Pay Cycle** window. For more information, see ["Payroll Integration Changes" \(page 76\)](#).

Materials Where-Used Inquiry

In Materials Where-Used Inquiry, you have the option to view material usage in either work tickets or templates. Also you can sort by multiple columns.

Payroll Integration Changes

The following changes related to integration with the Payroll module have been made in Production Management.

- The Periodic Labor Register has been renamed Periodic Labor Report. This report is no longer used to push labor entries to the Payroll module for use in Payroll Data

Entry.

- Labor entries are now imported into Payroll by clicking the **Labor** button on the **Pay Cycle** window. Labor Entry records can be imported into Payroll only if **Yes** is selected in the **(Integrate with) Payroll** field in **Production Management Options**.

Data Conversion for Work Order

If you're upgrading from an earlier version of Sage 100, Work Order data is included in your source company, and the Production Management module is installed in your target company, your Work Order data is converted to Production Management data.

Note: If you had purchase orders linked to work orders in your source data, the purchase orders will not be linked to the converted work tickets after you run conversion. You must manually relink the purchase orders.

Data Conversion for Earlier Version of Production Management

The Production Management module code has changed from JT to PM. When you convert Production Management data from an earlier version of Sage 100, the converted company data files are changed to use the PM prefix.

Important! If you're upgrading from the standalone version of Production Management that was previously available, you must be on version 2021.x of the standalone version before upgrading to the Production Management module that is part of Sage 100 2022.

Note: Report settings saved in the standalone version of Production Management are not migrated to the version of the module available with Sage 100 2022.

Sage Intelligence Reporting

Sage Intelligence Reporting now works with the 64-bit version of Sage 100 and Windows.

Sales Order

The following changes were made in the Sales Order module.

View Order Type, Ship Date, and Expire Date in History

The following fields have been added to the Sales Order and Quote History Inquiry window:

- Order Type
- Ship Date (for standard orders and back orders)
- Expire Date (for quotes)

These fields have also been added to the SO_SalesOrderQuoteHistoryWrk table, so they can be added to forms.

Visual Process Flows

The following changes were made to the Visual Process Flows Designer.

- Buttons with up/down and left/right arrows have been added to the Actions window. Use the buttons to move the Actions window to another area of the Designer window.
- Guidelines now appear when you start to move an element to help you align it with other elements in the Designer window.
- An **Underline** button has been added to the text formatting toolbar.
- You no longer have to press the Enter key to add text to an element.

Work Order

The Production Management module has replaced Work Order. The Work Order module is no longer part of the Sage 100 installation program.

When running conversion, if your source company has Work Order data and the Production Management module is installed for version 2022, the Work Order data is converted to Production Management data.

Note: If your data includes work orders that are linked to purchase orders, you will have to manually relink the purchase orders to work tickets after you convert the data.

Microsoft 365

References to Office 365, including task names, have been changed to Microsoft 365.

Features No Longer Subscription Only

The following features were initially available only if you purchased Sage 100 through a subscription plan. They are now available to all users, regardless of whether Sage 100 was purchased as a subscription or perpetual license.

- **Spell Check:** A red line appears underneath misspelled words. You can right-click the word to view a list of suggestions, ignore the misspelling, or add it to your custom dictionary.
- **Full Text Search in Lookups:** In Lookup views, in the **Search** list, you can select **Full Text**. Your search criteria is then matched against all text in the records instead of a single field.
- **Theme Maintenance:** This task, located on the Library Master Main menu, allows you to customize the appearance of Sage 100 windows.
- **Document Date Warnings:** This feature allows you to display a warning message when a user enters a date that is outside of settings defined in Company Maintenance.

The following changes are carried throughout multiple modules.

Company Types

You can now see at a glance whether the current company is live, a demo, and so forth. After selecting types for your companies in Company Maintenance and setting up display preferences in System Configuration, you can see the type in the title bar of your task windows.

Type Field in Company Maintenance

A Type field has been added in Company Maintenance. You must select one of the following options: Live, Archive, Demo, Test.

When you upgrade from an earlier version of Sage 100, Live is automatically selected for all companies that are converted, but you can change the type if needed.

When you install demo data, Demo is automatically selected as the company type.

Display Options in System Configuration

On the Preferences tab in System Configuration, check boxes for each company type have been added in the Display Company Type in Windows Title Bar section.

Select one or more of these check boxes to display the company type after the company code in the title bar for task windows.

For example: Customer Maintenance (ABC - Demo) 5/31/2025

Security Option to Delete or Overwrite Companies

A new security option has been added in Role Maintenance. If the Allow Delete/Overwrite Live and Archive Companies check box is selected, the applicable users will be able to delete or overwrite companies with Live or Archive selected as the type. A message appears to confirm the intention to delete or overwrite the company.

Check Number Field Expanded

- Purchase Order

- E-mail Address

User Logon is the default selection.

64-Bit Version of Sage 100

A 64-bit version of Sage 100 is now available. When running the Sage 100 installation wizard on a computer with a 64-bit version of Windows, you'll have the option to install either the 32-bit version or the 64-bit version.

Warnings!

- After installing the 64-bit version of Sage 100, any 32-bit versions installed on the same computer will no longer work.
- If you install the 64-bit version of Sage 100 then only workstations with the 64-bit version of Windows will be able to run Sage 100.

If you're installing Sage 100 on a computer with a 32-bit version, you can install the 32-bit version of Sage 100 2021, and then run the Sage 100 32-bit/64-bit Switch Utility Wizard after you've converted your data and completed your testing. This utility converts your 32-bit version of Sage 100 2021 to 64 bit.

If necessary you can also use the utility to convert from the 64-bit version of Sage 100 to the 32-bit version.

Payment Center Rebranding

Paya (formerly known as Sage Payment Solutions) has retired the Payment Center website and replaced it with the Paya Exchange website. Labels within Sage 100 have been changed from Payment Center to Paya Exchange.

Credit card and ACH payment processing work flows have not changed. Paya Desktop Connect has replaced Sage Exchange Desktop as the locally installed application that is required.

Edge Used for Embedded Browser

Microsoft Edge is now used as the embedded browser in the Sage 100 Desktop if you have a version of Edge installed that was released on or after January 15, 2020.

Edge is a more modern browser that delivers better page rendering and performance.

Map Sage 100 Users to Sage ID Accounts

A User Merge Utility has been added to the Administrative Tools window to help you map user records created in the Sage Provisioning Portal to user records created in Sage 100.

Use this utility when you're migrating data from an on-premises version of Sage 100 to one in the Sage Partner Cloud. For more information, see User Merge Utility in the help.

Accounts Payable

The following changes were made in the Accounts Payable module.

Form 1099-NEC Option in Form 1099 Tax Reporting

Nonemployee Compensation has been added to the Form Type list in Form 1099 Tax Reporting.

A/P Open Invoices Paid Today Utility

An Open Invoices Paid Today Utility has been added to the Sage 100 Utilities menu available from the Run Program window. Use this utility to ensure that the Paid Today field in the Open Invoice file is set correctly when related records are missing due to power loss or some other unusual circumstance. You can schedule the utility to run automatically using Task Scheduler.

Accounts Receivable

The following changes were made in the Accounts Receivable module.

Use Original or Current Cost When Applying Credit Memo

When applying a credit memo to an invoice in Invoice Data Entry, you have the option to recall Accounts Receivable invoice information from history. This option is available if Yes or Summary is selected in the (Invoice History) Retain in Detail field in Accounts Receivable Options.

After you enter an invoice number, a message asks if you want to copy invoice information from history.

If Yes is selected in the (Invoice History) Retain in Detail field, line details are included. If Summary is selected only the invoice header information is used.

If you click Yes to use information from the history files, a second message asks if you want to recall the item cost from history. You can click the Details button in the message window to view the cost information from both history and inventory for each item on the invoice. Check with your accountant about the appropriate costing method for returned inventory.

The posting book check boxes in the Period End Processing window have been replaced by a grid with Book Name and Close Book columns. The Close Book column contains check boxes that you can select for the books that you want to process for period end.

The change was made to support the additional posting books added in Sage Fixed Assets version 2021.

Inventory Management

The following changes were made in the Inventory Management module.

Default Date Range for Transactions

You can select a default date range for the Transactions tab in Item Maintenance and Item Inquiry.

The default date range is based on the selection in the Transaction Date Search Default Selection field that has been added to the Additional tab in Inventory Options.

When viewing the Transactions tab, you can change the default date range by clicking the Search button and entering different criteria in the Transaction Date row.

Library Master

Role Security Enhancements

Several security-related enhancements have been made to simplify the security setup process.

Security Menu

A Security Menu has been added to the Library Master module. This menu includes the tasks listed below. Some tasks are new and some were relocated from other menus.

- Administrator Tools
- Export Roles (subscription only)
- Import Roles (subscription only)
- Role Maintenance
- Role Report
- Role/User Inquiry (subscription only)

- User Maintenance
- User Report

Note: The Security menu is available for both subscription and non-subscription versions of Sage 100. However, some tasks are available only in the subscription version.

Role Maintenance Enhancements

The following changes were made in Role Maintenance.

Role Types

A Type field has been added with types such as Admin, Auditor, Employee, and so forth. You'll be required to select a type when creating new roles. Existing roles created in earlier versions of Sage 100 will automatically have Converted as the selected type, but you can change it.

Note: The Type field is available for both subscription and non-subscription versions of Sage 100.

Role Templates

When creating a role, you can click Copy and then select one of several predefined role templates. Templates have been added for most modules and are available based on which modules are installed.

To view a detailed list of permissions available with each role template, print the Role Report and select Role Template Details in the Type of Report to Print field. You can also view an existing template in Role Maintenance by clicking the Role Template List button and selecting a template.

Task Tab

On the Tasks tab, you can sort the module list alphabetically or by the default menu order. When the modules are sorted alphabetically, the subcategories are still sorted using the default menu order.

The security alias feature has been removed for various tasks. For example, Item Inquiry appears on the Sales Order Inquiries menu. In earlier versions of Role Maintenance, you

would have to go to the Inventory Management section to grant access to Item Inquiry in the Sales Order module. Item Inquiry is now included in the Sales Order section.

Security Options

Security events and module options have been combined onto one tab in Role Maintenance, and they are now referred to as Security Options.

On the Security Options tab, you can sort by module, group, or security option. When you sort by group, the security options are still organized by module, but there are subcategories such as Batches, Data Entry, and so forth.

Help text for the selected security option is displayed at the bottom of the window.

Filtering Role Settings

A Filter button has been added in Role Maintenance. Click this button to open the Filter Role Settings window, which you can use to filter the information that appears in the tree view on the various tabs.

This window provides several filter options, such as by module and menu group. You can apply the filter to all tabs or certain ones.

Applying Role Changes to Other Roles

After making a change to a role, you can click the Apply button to open the Apply Role Changes window. In this window, you can select which changes to apply and to which roles they should be applied.

Assigning Users to Roles

Click the Assign button to open the Assign Users to Role window. Use this window to assign the current role to users in some or all companies.

Removing Users from Roles

Click the Remove button to open the Remove Users from Role window. Use this window to remove users from the current role.

Importing and Exporting Roles

Click the Import and Export buttons to import and export roles. You must click the buttons before selecting a role.

When you export roles, they are exported to the file and location that you specify. When you Import a role, you can select which of the roles included in the import file that you want to import.

Role Report Enhancements

When printing the Role Report, you can select Role Template Details in the Type of Report to Print field to view a list of all permissions available for one or more role templates. A Role Template field has been added to the Selections grid.

The Include Tasks and Events with No Access check box that was added in the 2020.1 update has been replaced with an Include Tasks and Options field. Use this field to specify whether to print tasks and security options for which the role has access, no access, or both.

Options for sorting tasks and security options have been added.

The role type now prints on the report for both subscription and non-subscription plans.

Exclude Role Option in User Maintenance

An Exclude check box has been added to the Maintenance tab in User Maintenance. Use this check box if you've assigned a role to a user for all companies, but want to exclude them from the role in specific companies.

User Report Enhancements

The Include Tasks and Events with No Access option that was added in the 2020.1 update has been replaced with an Include Tasks and Options field. Use this field to specify whether to print tasks and security options for which the user has either access, no access, or both.

Options for sorting tasks and security options have been added.

Role/User Inquiry

Role/User Inquiry has been added to the Security menu. Use this task to select a role, user, task, or security option and view related information about the selected item. The information is displayed in a tree view and can be exported to Excel.

Maintain Default Form Codes

A new task, Default Form Maintenance, has been added to the Library Master Setup menu.

Use this task to:

- Maintain default form codes by company and role or individual user.
- Select a template for Standard form codes if there is no template already associated with the code.
- Prevent users from changing the default form code within the form tasks.

Access Administrative Tools

OAuth Authentication for SMTP Mail Server

On the E-mail tab in Company Maintenance, you can now select between two authentication methods to use when connecting to the SMTP server:

- **Basic:** This option works the same as earlier versions of Sage.
- **OAuth (Open Authorization):** This new option is an open standard authorization protocol used to grant access using access tokens instead of sharing a user name and password.

If you're going to use the OAuth method, you will need to obtain your OAuth client credentials from your authenticating application, such as those offered by Microsoft and Google. To learn more, visit oauth.net.

ACA PII Worktable Available in Report Manager

When adding a Payroll report using the Report Manager wizard, you have the option to include the ACA PII (personally identifiable information) worktable in the report.

Paperless Office

The following changes were made in the Paperless Office module.

Default Delivery Options

A new Default Delivery Options task has been added to the Paperless Office Setup menu. Use this task to make default form selections that are automatically set in the Paperless Office Delivery Options window when creating a new customer or vendor record. You can change the defaults if needed.

Select a document and then click this button to view the most recent date and time that the document was sent, the user logon of the person who sent it, the status of the submission attempt, and the recipient's email or fax number.

Click the Electronic Delivery Submissions List button to view a list of all attempts to send the document.

View List of Documents That Have Been Sent

Two inquiry tasks have been added to the Paperless Office Main menu:

- Customer Electronic Delivery Inquiry
- Vendor Electronic Delivery Inquiry

Use these tasks to view a list of documents that have been sent to customers and vendors.

You have several options for filtering the list, including the delivery type and status. The status reflects whether emails were successfully submitted to the SMTP server and whether faxes were successfully submitted to the fax server.

You can resend the documents from the list box or export the list to Microsoft Excel.

New Options for Associated Documents

You are no longer limited to PDF files when associating documents with journals and registers. Any document type can be associated, including Word documents, Excel workbooks, images, and so forth. Field labels in various windows have been updated to reflect the change.

In the Journal and Register Viewer, you can click the Edit Associated Document button to:

- Select a different document to associate with the journal or register.
- Add a document if none was previously associated.
- Remove an associated document.

The button is available based on a new security option, Allow Editing of Associated Document for Journal and Register PDF Documents.

Documents are Updated Only If Printed and Sent

The Purchases Clearing From History Report has been added to the Purchase Order Period End Processing menu.

Unlike the Purchases Clearing Report, you can run this report after running period end processing, so you can get the information needed to reconcile the purchases clearing account at any time.

Invoice Lines Added in Receipt History Inquiry

When viewing a receipt of invoice record in Receipt History Inquiry, the invoice lines now appear on the Lines tab.

Invoice Lines Added to Receipt History Report

Line details from receipt of invoice records are now included on the Receipt History Report when you select the Print Line Information check box if you're retaining history in Purchase Order Options.

Drill Down Options in Purchase Order Entry and Inquiry

Two drill-down buttons have been added to the Totals tab in Purchase Order Entry and Purchase Order Inquiry.

A **Receipt History Inquiry** button has been added next to the Last Receipt Date field. If one or more receipts exist for the purchase order, you can click the button to view the receipt(s).

An **Invoice History Inquiry** button has been added next to the Last Invoice Date field. If one or more invoices exist for the purchase order, you can click the button to view the invoice(s).

Note: During data conversion, the program attempts to populate the P/O Receipts History Detail file using line detail from the A/P Invoice History Detail file for existing Receipt of Invoice Records. However, the line detail will not be populated if the line detail does not exist in the A/P file.

Form 1099-NEC Option Available

You can select the 1099-Nonemployee Comp form when entering a document in the following tasks:

- Purchase Order Entry
- Receipt of Goods Entry
- Receipt of Invoice Entry
- Return of Goods Entry

To automatically print the reports without prompts, go to Sales Order Options and, on the Printing tab, select the Automatically Print All Additional Reports That Apply check box.

The reports listed above are available based on how the Sales Order module is set up.

Use Original or Current Cost When Applying Credit Memo

When applying a credit memo to an invoice in Invoice Data Entry, you have the option to recall invoice information from history. This option is available if Yes or Summary is selected in the (Invoice History) Retain in Detail field in Accounts Receivable Options.

After you enter an invoice number, a message asks if you want to copy invoice information from history.

If Yes is selected in the (Invoice History) Retain in Detail field, line details are included. If Summary is selected only the invoice header information is used.

If you click Yes to use information from the history files, a second message asks if you want to recall the item cost from history. You can click the Details button in the message

window to view the cost information from both history and inventory for each item on the invoice. Check with your accountant about the appropriate costing method for returned inventory.

Visual Integrator

Options for Managing Log Files

A Setup menu has been added to the Visual Integrator module. Visual Integrator Options has been added to the menu.

In Visual Integrator Options you can manage the log files that are generated when running import and export jobs and when automatically scheduled jobs are run.

You can specify whether to reuse the existing log files when jobs are run or create new ones. You can also select the location where log files are saved.

Visual Process Flows

Visual Process Flows are now based on HTML5 instead of Adobe Flash. The new visual process flows feature a blue and white color scheme and new images. Some images are no longer available.

Tool tips no longer appear when hovering over an icon. Instead you must click the icon to see the tool tip. If a visual process flow had multiple tool tips, they have been combined.

By default, tool tips, print options, report options, and inquiry selections are shown. After opening a visual process flow, click twice on an icon to hide the corresponding information. After you've hidden the information, you can click once to show it or hide it again.

If you've created custom visual process flows in earlier versions of Sage 100, they will still work, with the exception of the show/hide functionality. However, you should review them because adjustments may be needed.

The editor for customizing visual process flows has been redesigned.

Office 365 Integration

A new task, Self Service Invitations, has been added to the Office 365 Integration menu in the Library Master module. Use this task to send email invitations to employees so that they can start using the employee self service features.

2. If your system is integrated with Sage CRM, go into CRM Server Options, and update the following information as needed.

- Integration server port ID
- Sage CRM SQL server name
- Sage CRM SQL database name

The server name and database name should reference the mirror installation that you created for integration with Sage 100 2026. For more information on this process, see the [Sage CRM Help Center](#).

After updating the information, load the Sage CRM data.

3. If you synchronize payroll data between your General Ledger module and Sage Payroll Services, verify that your Sage 100 company or companies are still linked to the service.
 - a. Select General Ledger > Payroll Services > Payroll Services Synchronization Wizard.
 - b. Sign in to Sage Payroll Services.
 - c. Proceed through the wizard.
 - d. Review the status messages shown in the Synchronizing Data with Sage Payroll Services window.

If you see a "Synchronization Complete" message, no further action is required.

If you see a "Synchronization failed" message, contact iSolved Support for assistance with resetting the link.

4. Update customized panels by selecting Custom Office Utilities menu > Update Customized Panels to Current Level. Review the placement of all user-defined fields.
5. If you have customized Advanced Lookup Engine (ALE) lookups, after converting to the new version of the software and prior to accessing other modules, select Library Master Utilities menu > Lookup Conversion to convert your lookups.
6. Verify that all module links are functional by selecting Library Master Utilities menu > Link Maintenance Utility. Links that appear in red are broken and will need to be fixed using the Relink button in Link Maintenance Utility. For more information on relinking files, see Copy/Move/Relink Files in your Help system.
7. If you are also upgrading your Payroll Module, review the list of enhancements and upgrade instructions in the *Sage 100 Payroll Installation and Upgrade Guide*, available on the [Sage 100 Documents page](#).
8. Test your customized Crystal reports and forms.
 - If you need to troubleshoot issues with customized reports and forms, run the Crystal Form Comparison Report utility to compare your customized reports and forms to the standard ones in version 2026.

To run the utility, select File menu > Run, and then type **SYWFCU**. The utility tells you which tables, if any, have been added to a report or form. It does not provide information about formatting changes, such as those affecting fonts, logos, and so forth.

- If you were previously using non-graphical forms, you will need to set them up using SAP Crystal Reports.
 - If you are using Sage 100 Standard or Sage 100 Advanced, use the Crystal Reports Conversion Wizard to convert your Crystal reports and forms. For more information, see *SAP Crystal Reports FAQs* in the Help system. If you do not run the wizard now, it will automatically run the first time that someone runs a form or report.
 - If you are using Sage 100 Premium, refer to the Converting Reports for Sage 100 Premium section in the *Sage 100 Installation and System Administrator's Guide* for more information.
9. If Sage 100 2026 is installed on the same computer as an earlier version of Sage 100, complete this step to avoid errors when printing forms and reports in the earlier version:
- Copy the pvxwin32.exe.config file from the ..\MAS90\Home folder in your 2021 installation to the same folder in your 2026 installation. You must complete this step on both the server and the workstation.
10. If your system has custom reports, review the Custom Reports menus to make sure they are available. If they are not, add them using Report Manager.
11. If you use Sage Intelligence Reporting, create a new repository for use with the latest version of Sage 100 and import any custom reports into it. For detailed instructions, see the ["Upgrading Sage Intelligence Reporting" \(page 153\)](#) checklist.
12. Review the Paperless Office module configuration for emailing statements, reports, journals, registers, and other forms. For more information, see *Set Up Paperless Office* in the Help.
13. Review your Business Insights Dashboard pages. For more information, see *Set Up Business Insights Dashboard* in the Help.
14. To use the eBusiness Manager module:
- a. Restore the copied templates back to the IW folder after re-installing the Web Engine.
 - b. Copy the poweredby.gif image from the MAS90\Images folder to the IIS Inetpub\wwwroot\images folder and restart the IIS Web service.
15. If you converted Work Order data to Production Management data, purchase orders that were linked to work orders must be relinked to work tickets. Use either of the following methods to relink:

- Use the Work Ticket to Purchase Order Post-Conversion Link Utility. Select File menu > Run, type ***utl** in the Run Program window, and click **OK**. In the Sage 100 Utilities window, select the utility and click **OK**.
 - Manually relink by selecting the purchase order in Purchase Order Entry and entering the applicable work ticket number in the **Work Ticket No.** field on the **Lines** tab.
16. If you use Custom Financials Reporting, you must unhide the menu and tasks. Select File menu > Run and type ***unhidegl** in the Run Program window.
 17. Print all customized form definitions and compare them to the ones previously printed. Default forms may be erased in the upgrade process.
 18. If you purchased the Return Merchandise Authorization module, after setting up the data files for the first time, select Return Merchandise Authorization Setup menu > Create Customer Invoice Search Records to create customer invoice search records in RMA.
 19. To run Microsoft Script links, you must have the Microsoft Windows Script Host processor on your system. For information on installing the Microsoft Windows Script Host processor, refer to the Microsoft Download Center website.
 20. If you use Automatic Update or Task Scheduler, review your scheduled automatic updates and reschedule those updates by selecting Library Master Main menu > Automatic Update or Task Scheduler, as applicable.
 21. If you were using the classic Desktop, which is no longer available, and had task folders in your My Tasks area, you can add tasks to the Favorites list instead. For more information, see *Add Items to the Favorites Content Group* in the Help.
 22. Test all printers, including Device Configurator printers, that you normally use for printing forms and reports. Each workstation must have a default printer defined.
 23. To use the auto-complete feature with enhanced search, run the Build Search Index utility to index your existing customer, vendor, and item records. To run the utility, select Library Master > Utilities > Build Search Index.
 24. Install Paya Connect Desktop on each workstation for each Windows user who needs to access credit card and ACH payment information in Sage 100.

To install Paya Connect Desktop for Sage 100 Standard:

- a. Use File Explorer to browse to the MAS90\Wksetup folder.

If you are installing Paya Connect Desktop on a workstation that connects to a Sage 100 Standard installation on a server, browser to the MAS90\Wksetup folder on the server.

- b. Double-click Autorun.exe to open the Workstation Setup program; it takes a few seconds to launch.
- c. Click Install Paya Connect Desktop.
- d. Proceed through the steps in the Paya Connect Desktop installation wizard to install the program.

To install Paya Connect Desktop for Sage 100 Advanced and Premium:

- a. Use File Explorer to browse to the server where Sage 100 is installed, and locate the MAS90\Wksetup folder.
- b. Double-click Autorun.exe to open the Workstation Setup program; it takes a few seconds to launch.
- c. Click Install Paya Connect Desktop.
- d. Proceed through the steps in the Paya Connect Desktop installation wizard to install the program.

Upgrading Sage Intelligence Reporting

If you use Sage Intelligence Reporting, follow the steps in this chapter to create a new repository for Sage 100 2026. If you have custom reports, follow the instructions to export custom reports from your prior version of the program and import them into the new repository.

Report Compatibility

Reports can be imported only from an earlier version of the program or another instance of the same version. For example, you can import a report created in version 2013 into version 2026. You **cannot** import a report created in version 2026 into version 2013.

Reports created in Sage 100 Standard and Sage 100 Advanced are not compatible with Sage 100 Premium. Likewise, reports created in Sage 100 Premium are not compatible with Sage 100 Standard and Sage 100 Advanced.

Export Custom Reports

In your prior version of Sage 100, export all of the custom reports that you want to use in version 2026.

To export custom reports

1. In your prior version of Sage 100, select Sage Intelligence Reporting Main menu > Report Manager.
2. Right-click a report and then click Export Report. (Alternately, select a report and then, on the Tools menu, click Export Report.)

3. Select the location where you want to save the file and then click Save. A file with an AL_ extension is created.
4. Repeat these steps for all custom reports that you want to use in version 2026.

Create a New Repository

Create a shared folder to use as the Sage Intelligence Reporting repository for Sage 100 2026. We recommend using a separate repository for each installation of Sage Intelligence Reporting.

Note: These steps may vary depending on what version of Windows you are using. Check with your network administrator if you need assistance.

To create a repository

1. Use Windows File Explorer to create a folder in the desired location.
2. Right-click the folder, point to "Share with," and click "Advanced sharing."
3. On the Sharing tab, select the "Share this folder" check box.
4. Enter a share name.
5. Click Permissions.
6. For all applicable users, select the Full Control or Read and Write check boxes.
7. Click OK.
8. If you use reporting trees or distribution settings, copy the following folders from the old repository to the new one:
 - Report Trees
 - Distribution

Set Up Sage Intelligence Reporting in Sage 100 2026

After creating the shared folder, enter its location in Sage 100 2026. If you haven't already registered your 2026 version of Sage Intelligence Reporting, you will be asked to do so.

To set up Sage Intelligence Reporting

1. In Sage 100 2026, select Sage Intelligence Reporting Main menu > Report Manager.
2. Click File and then click Change.
3. Click Yes in the message window.
4. In the Network Repository Path field, type the UNC path to the shared folder that you created. For example: \\ServerName\ReportRepository
5. Click OK.
6. If you receive a message asking you to register Sage Intelligence Reporting, click OK to open the License Manager window.
7. In the Account Number field, enter your Sage customer number.
8. In the Serial Number field, enter your unlocking key. This field is case-sensitive.
9. Click Apply and then click Perform Registration.

Import Custom Reports

After creating the new repository and registering Sage Intelligence Reporting, import any custom report files.

To import custom reports

1. If you want to create folders to organize your reports, on the Home tab, click Add Folder.
2. Right-click either the Home folder or any custom folder created in the prior step, and then click Import Report. (Alternately, you can click the Tools tab, and then click Import Report.)
3. Select one of the custom reports that you exported from your prior version.

4. In the Import Report window, in the Target Connection field, select a connection.
 - For consolidated reports, select Sage MAS Consolidation.

Note: You must own the Sage 100 Intelligence Connector module to generate consolidated reports.

- For any other type of report, select Sage MAS (Auto Connect).
5. In the Report Destination field, select the folder for the report.
 6. Click Import.
 7. On the Home tab in the Actions group, click Refresh.
 8. Repeat these steps for any other custom reports that you exported from your prior version of Sage Intelligence Reporting.

Converting to 64-bit Version of Sage 100 2021-2025

Important! Sage 100 2026 is a 64-bit only application.

- If you're installing on a server with an earlier 32-bit version of Sage 100 2021-2025 installed, **the 32-bit version will no longer work.**
- Before installing Sage 100 2026, we recommend converting any earlier 32-bit versions to 64-bit using the 32_64_Bit_Switch_Utility.exe.
- If running the switch utility is not possible, then install Sage 100 2026 on a server that does not have a 32-bit version installed.

The following table shows the bit versions for Sage 100.

Feature	Sage 100 2020 and Earlier	Sage 100 2021-2025	Sage 100 2026
Bit version	32-bit only	32-bit or 64-bit	64-bit only

Before you begin

Create a backup of the data from your 32-bit version of Sage 100 2021-2025.

To convert from 32-bit to 64-bit

1. On the server where you will install Sage 100 2026, open the folder where the Sage 100 installation program is located for the earlier 32-bit version of Sage 100 2021-2025.

Note: For example, if you're converting a 32-bit version of Sage 100 2024, use the Sage 100 2024 installation program.

2. Click or double-click the 32_64_Bit_Switch_Utility.exe file.
3. Click Next and then enter the password for the Sage 100 Administrator account.
4. Click Convert.

Sage 100 is converted to the 64-bit version.

The Workstation Synchronization program automatically upgrades the workstations the next time Sage 100 is started on the workstation.
